Q1 :

Assign oxidation numbers to the underlined elements in each of the following species:

(a)  $\text{NaH}_2 \underline{PO}_4$  (b)  $\text{NaH}\underline{SO}_4$  (c)  $\text{H}_4 \underline{P}_2 O_7$  (d)  $\text{K}_2 \underline{\text{Mn}} O_4$ 

(e)  $CaO_2$  (f)  $NaBH_4$  (g)  $H_2S_2O_7$  (h)  $KAI(SO_4)_2.12 H_2O$ 

Answer :

(a)  $NaH_2 PO_4$ 

Let the oxidation number of P be x.

We know that,

Oxidation number of Na = +1

Oxidation number of H = +1

Oxidation number of O = –2

$$\Rightarrow \operatorname{Na}^{+1}_{H_2} \operatorname{PO}_4^{x^{-2}}$$

Then, we have

$$1(+1) + 2(+1) + 1(x) + 4(-2) = 0$$
  

$$\Rightarrow 1 + 2 + x - 8 = 0$$
  

$$\Rightarrow x = +5$$

Hence, the oxidation number of P is +5.

(b) NaHSO4

Na HSO4

Then, we have

1(+1)+1(+1)+1(x)+4(-2) = 0  $\Rightarrow 1+1+x-8 = 0$  $\Rightarrow x = +6$ 

Hence, the oxidation number of S is + 6.

(c)

Then, we have

$$4(+1)+2(x)+7(-2)=0$$
  

$$\Rightarrow 4+2x-14=0$$
  

$$\Rightarrow 2x = +10$$
  

$$\Rightarrow x = +5$$

Hence, the oxidation number of P is + 5.

(d)

 $K_2 M n O_4$ 

Then, we have

$$2(+1) + x + 4(-2) = 0$$
  
$$\Rightarrow 2 + x - 8 = 0$$
  
$$\Rightarrow x = +6$$

Hence, the oxidation number of Mn is + 6.

(e)  $CaO_2$  $\overset{+2}{\operatorname{Ca}}\overset{x}{\operatorname{O}}_2$ 

Then, we have

$$(+2)+2(x) = 0$$
$$\Rightarrow 2+2x = 0$$
$$\Rightarrow x = -1$$

Hence, the oxidation number of O is – 1.

(f)  $Na\underline{B}H_4$  $\operatorname{Na}^{+1}_{\operatorname{B}} \operatorname{B}^{x}_{\operatorname{H}^{-1}}_{\operatorname{H}^{4}}$ 

Then, we have

$$1(+1)+1(x)+4(-1) = 0$$
  
$$\Rightarrow 1+x-4 = 0$$
  
$$\Rightarrow x = +3$$

Hence, the oxidation number of B is + 3.

(g)

Then, we have

$$2(+1)+2(x)+7(-2) =$$
  

$$\Rightarrow 2+2x-14 = 0$$
  

$$\Rightarrow 2x = 12$$
  

$$\Rightarrow x = +6$$

Hence, the oxidation number of S is + 6.

(h) 
$$\frac{\text{KAl}(\underline{SO}_4)_2.12\text{H}_2\text{O}}{\frac{1}{K} \frac{1}{Al} \left( \frac{x}{SO_4} \right)_2.12 \frac{1}{H_2} \frac{-2}{O}}{1.12 \frac{1}{H_2} \frac{-2}{O}}$$
  
Then, we have

1(+1)+1(+3)+2(x)+8(-2)+24(+1)+12(-2) = 0  $\Rightarrow 1+3+2x-16+24-24 = 0$   $\Rightarrow 2x = 12$  $\Rightarrow x = +6$ 

Or,

We can ignore the water molecule as it is a neutral molecule. Then, the sum of the oxidation numbers of all atoms of the water molecule may be taken as zero. Therefore, after ignoring the water molecule, we have

$$1(+1)+1(+3)+2(x)+8(-2) = 0$$
  

$$\Rightarrow 1+3+2x-16 = 0$$
  

$$\Rightarrow 2x = 12$$
  

$$\Rightarrow x = +6$$

Hence, the oxidation number of S is + 6.

#### Q2 :

What are the oxidation numbers of the underlined elements in each of the following and how do you rationalise your results?

(a) KI<sub>3</sub> (b)  $H_2S_4O_6$  (c) <u>Fe</u><sub>3</sub>O<sub>4</sub> (d) <u>C</u>H<sub>3</sub><u>C</u>H<sub>2</sub>OH (e) <u>C</u>H<sub>3</sub><u>C</u>OOH

Answer :

(a) K<u>I</u>₃

1

In KI<sub>3</sub>, the oxidation number (O.N.) of K is +1. Hence, the average oxidation number of I is  $\overline{3}$ . However, O.N. cannot be fractional. Therefore, we will have to consider the structure of KI<sub>3</sub>to find the oxidation states.

In a KI<sub>3</sub>molecule, an atom of iodine forms a coordinate covalent bond with an iodine molecule.

$$\overset{^{+1}}{K^{^+}} \left[ \overset{^{0}}{\mathrm{I}} - \overset{^{0}}{\mathrm{I}} \leftarrow \overset{^{-1}}{\mathrm{I}} \right]^{^-}$$

Hence, in a KI<sub>3</sub>molecule, the O.N. of the two I atoms forming the I<sub>2</sub>molecule is 0, whereas the O.N. of the I atom forming the coordinate bond is  $\hat{a} \in 1$ .

$$H_2 SO_4 O_6$$

Now, 
$$2(+1) + 4(x) + 6(-2) = 0$$
  
 $\Rightarrow 2 + 4x - 12 = 0$   
 $\Rightarrow 4x = 10$   
 $\Rightarrow x = +2\frac{1}{2}$ 

However, O.N. cannot be fractional. Hence, S must be present in different oxidation states in the molecule.

$$H = O = S = S = S = S = S = O = H$$

The O.N. of two of the four S atoms is +5 and the O.N. of the other two S atoms is 0.

(c) 
$$\underline{Fe}_{3}O_{4}$$

On taking the O.N. of O as  $\hat{a} \in 2$ , the O.N. of Fe is found to be  $+2\frac{-}{3}$ . However, O.N. cannot be fractional. Here, one of the three Fe atoms exhibits the O.N. of +2 and the other two Fe atoms exhibit the O.N. of +3.

(d)  $CH_3CH_2OH$   
2 (x) + 6 (+1) + 1 (-2) = 0  
or, 2x + 4 = 0  
or, x = -2  
Hence, the O.N. of C is –2.  
(e)  $CH_3COOH$

2(x) + 4(+1) + 2(-2) = 0

or, 2x = 0

or, x = 0

However, 0 is average O.N. of C. The two carbon atoms present in this molecule are present in different environments. Hence, they cannot have the same oxidation number. Thus, C exhibits the oxidation states of +2 and  $\hat{a} \in 2$  in CH<sub>3</sub>COOH.

Q3 :

Justify that the following reactions are redox reactions:

(a) CuO(s) + H<sub>2</sub>(g)  $\rightarrow$  Cu(s) + H<sub>2</sub>O(g)

(b)  $Fe_2O_3(s) + 3CO(g) \rightarrow 2Fe(s) + 3CO_2(g)$ 

(c)  $4BCI_3(g) + 3LiAIH_4(s) \rightarrow 2B_2H_6(g) + 3LiCI(s) + 3AICI_3(s)$ 

- (d) 2K(s) + F<sub>2</sub>(g)  $\rightarrow$  2K+F- (s)
- (e)  $4 \text{ NH}_3(g) + 5 \text{ O}_2(g) \rightarrow 4 \text{NO}(g) + 6 \text{H}_2 \text{O}(g)$

#### Answer :

(a) 
$$\operatorname{CuO}_{(s)} + \operatorname{H}_{2(g)} \longrightarrow \operatorname{Cu}_{(s)} + \operatorname{H}_{2}\operatorname{O}_{(g)}$$

Let us write the oxidation number of each element involved in the given reaction as:

$$\overset{+2}{\operatorname{Cu}}\overset{-2}{\operatorname{O}}_{(s)} + \overset{0}{\operatorname{H}}_{2(g)} \longrightarrow \overset{0}{\operatorname{Cu}}_{(s)} + \overset{+1}{\operatorname{H}}_{2}\overset{-2}{\operatorname{O}}_{(g)}$$

Here, the oxidation number of Cu decreases from +2 in CuO to 0 in Cu i.e., CuO is reduced to Cu. Also, the oxidation number of H increases from 0 in  $H_2$  to +1 in  $H_2$ O i.e.,  $H_2$  is oxidized to  $H_2$ O. Hence, this reaction is a redox reaction.

(b) 
$$\operatorname{Fe}_2\operatorname{O}_{3(s)} + 3\operatorname{CO}_{(g)} \longrightarrow 2\operatorname{Fe}_{(s)} + 3\operatorname{CO}_{2(g)}$$

Let us write the oxidation number of each element in the given reaction as:

$$\overset{+3}{\mathrm{F}}\mathrm{e}_{2}\overset{-2}{\mathrm{O}_{3(s)}} + 3\overset{+2}{\mathrm{C}}\overset{-2}{\mathrm{O}_{(g)}} \longrightarrow 2\overset{0}{\mathrm{F}}\mathrm{e}_{(s)} + 3\overset{+4}{\mathrm{C}}\overset{-2}{\mathrm{O}_{2(g)}}$$

Here, the oxidation number of Fe decreases from +3 in Fe<sub>2</sub>O<sub>3</sub> to 0 in Fe i.e., Fe<sub>2</sub>O<sub>3</sub> is reduced to Fe. On the other hand, the oxidation number of C increases from +2 in CO to +4 in CO<sub>2</sub> i.e., CO is oxidized to CO<sub>2</sub>. Hence, the given reaction is a redox reaction.

(c) 
$$4BCl_{3(g)} + 3LiAlH_{4(g)} \longrightarrow 2B_2H_{6(g)} + 3LiCl_{(g)} + 3AlCl_{3(g)}$$

The oxidation number of each element in the given reaction can be represented as:

$$4 \overset{+3}{\text{B}} \overset{-1}{\text{Cl}}_{3(g)} + 3 \overset{+1}{\text{L}} \overset{+3}{\text{I}} \overset{-1}{\text{H}}_{4(s)} \longrightarrow 2 \overset{-3}{\text{B}}_{2} \overset{+1}{\text{H}}_{6(g)} + 3 \overset{+1}{\text{L}} \overset{-1}{\text{Cl}}_{(s)} + 3 \overset{+3}{\text{A}} \overset{-1}{\text{Cl}}_{3(s)}$$

In this reaction, the oxidation number of B decreases from +3 in BCl<sub>3</sub> to  $\hat{a} \in 3$  in B<sub>2</sub>H<sub>6</sub>. i.e., BCl<sub>3</sub> is reduced to B<sub>2</sub>H<sub>6</sub>. Also, the oxidation number of H increases from  $\hat{a} \in 1$  in LiAlH<sub>4</sub> to +1 in B<sub>2</sub>H<sub>6</sub> i.e., LiAlH<sub>4</sub> is oxidized to B<sub>2</sub>H<sub>6</sub>. Hence, the given reaction is a redox reaction.

(d) 
$$2K_{(s)} + F_{2(g)} \longrightarrow 2K^+F^-_{(s)}$$

The oxidation number of each element in the given reaction can be represented as:

$$2 \overset{0}{K}_{(s)} + \overset{0}{F}_{2(g)} \longrightarrow 2 \overset{+1}{K}^{+} \overset{-1}{F}_{(s)}^{-}$$

In this reaction, the oxidation number of K increases from 0 in K to +1 in KF i.e., K is oxidized to KF. On the other hand, the oxidation number of F decreases from 0 in  $F_2$  to  $a \in 1$  in KF i.e.,  $F_2$  is reduced to KF.

Hence, the above reaction is a redox reaction.

(e) 
$$4\mathrm{NH}_{3(g)} + 5\mathrm{O}_{2(g)} \longrightarrow 4\mathrm{NO}_{(g)} + 6\mathrm{H}_{2}\mathrm{O}_{(g)}$$

The oxidation number of each element in the given reaction can be represented as:

$$4 \overset{-3}{\mathrm{N}} \overset{+1}{\mathrm{H}_{3(g)}} + 5 \overset{0}{\mathrm{O}_{2(g)}} \longrightarrow 4 \overset{+2}{\mathrm{N}} \overset{-2}{\mathrm{O}_{(g)}} + 6 \overset{+1}{\mathrm{H}_{2}} \overset{-2}{\mathrm{O}_{(g)}}$$

Here, the oxidation number of N increases from  $\hat{a} \in 3$  in NH<sub>3</sub> to +2 in NO. On the other hand, the oxidation number of O<sub>2</sub>decreases from 0 in O<sub>2</sub> to  $\hat{a} \in 2$  in NO and H<sub>2</sub>O i.e., O<sub>2</sub> is reduced. Hence, the given reaction is a redox reaction.

#### Q4 :

Fluorine reacts with ice and results in the change:

 $H_2O(s) + F_2(g) \rightarrow HF(g) + HOF(g)$ 

Justify that this reaction is a redox reaction.

#### Answer :

Let us write the oxidation number of each atom involved in the given reaction above its symbol as:

$$\overset{+1}{H_2} \overset{-2}{O} + \overset{0}{F_2} \longrightarrow \overset{+1}{H} \overset{-1}{F} + \overset{+1}{H} \overset{-2}{O} \overset{+1}{F}$$

Here, we have observed that the oxidation number of F increases from 0 in  $F_2$  to +1 in HOF. Also, the oxidation number decreases from 0 in  $F_2$  to  $\hat{a} \in 1$  in HF. Thus, in the above reaction, F is both oxidized and reduced. Hence, the given reaction is a redox reaction.

#### Q5 :

Calculate the oxidation number of sulphur, chromium and nitrogen in  $H_2SO_5$ ,  $Cr_2O_7^{2-}$  and  $NO_3^{-}$   $\hat{a}\in$ ". Suggest structure of these compounds. Count for the fallacy.

Answer :

(i) 
$$H_2^{+1} \overset{x \to -2}{SO_5}$$
  
 $2(+1) + 1(x) + 5(-2) = 0$   
 $\Rightarrow 2 + x - 10 = 0$   
 $\Rightarrow x = +8$ 

However, the O.N. of S cannot be +8. S has six valence electrons. Therefore, the O.N. of S cannot be more than +6. The structure of  $H_2SO_5$  is shown as follows:

Here, there is no fallacy about the O.N. of  $Cr_1 O_7^{2-}$ .

The structure of  $Cr_2O_7^{2-}$  is shown as follows:

Here, each of the two Cr atoms exhibits the O.N. of +6.

#### Q8 :

While sulphur dioxide and hydrogen peroxide can act as oxidising as well as reducing agents in their reactions, ozone and nitric acid act only as oxidants. Why?

Answer :

## <mark>∛S</mark>aral

In sulphur dioxide  $(SO_2)$ , the oxidation number (O.N.) of S is +4 and the range of the O.N. that S can have is from +6 to -2.

Therefore, SO<sub>2</sub>can act as an oxidising as well as a reducing agent.

In hydrogen peroxide ( $H_2O_2$ ), the O.N. of O is -1 and the range of the O.N. that O can have is from 0 to -2. O can sometimes also attain the oxidation numbers +1 and +2. Hence,  $H_2O_2$ can act as an oxidising as well as a reducing agent.

In ozone ( $O_3$ ), the O.N. of O is zero and the range of the O.N. that O can have is from 0 to -2. Therefore, the O.N. of O can only decrease in this case. Hence,  $O_3$  acts only as an oxidant.

In nitric acid (HNO<sub>3</sub>), the O.N. of N is +5 and the range of the O.N. that N can have is from +5 to -3. Therefore, the O.N. of N can only decrease in this case. Hence, HNO<sub>3</sub> acts only as an oxidant.

Q9 :

Consider the reactions:

(a)  $6 \text{ CO}_2(g) + 6H_2O(I) \rightarrow C_6H_{12}O_6(aq) + 6O_2(g)$ 

(b)  $O_3(g) + H_2O_2(I) \rightarrow H_2O(I) + 2O_2(g)$ 

Why it is more appropriate to write these reactions as:

(a)  $6CO_2(g) + 12H_2O(I) \rightarrow C_6H_{12}O_6(aq) + 6H_2O(I) + 6O_2(g)$ 

(b)  $O_3(g) + H_2O_2(I) \rightarrow H_2O(I) + O_2(g) + O_2(g)$ 

Also suggest a technique to investigate the path of the above (a) and (b) redox

reactions.

#### Answer :

(a)The process of photosynthesis involves two steps.

#### Step 1:

 $H_2O$  decomposes to give  $H_2$  and  $O_2$ .

$$2H_2O_{(l)} \longrightarrow 2H_{2(g)} + O_{2(g)}$$

#### Step 2:

The  $H_2$  produced in step 1 reduces CO<sub>2</sub>, thereby producing glucose (C<sub>6</sub>H<sub>12</sub>O<sub>6</sub>) and H<sub>2</sub>O.

$$6 \operatorname{CO}_{2(g)} + 12 \operatorname{H}_{2(g)} \longrightarrow \operatorname{C}_6 \operatorname{H}_{12} \operatorname{O}_{6(s)} + 6 \operatorname{H}_2 \operatorname{O}_{(l)}$$

Now, the net reaction of the process is given as:

$$2 \operatorname{H}_{2}\operatorname{O}_{(l)} \longrightarrow 2 \operatorname{H}_{2(g)} + \operatorname{O}_{2(g)} ] \times 6$$

$$6 \operatorname{CO}_{2(g)} + 12 \operatorname{H}_{2(g)} \longrightarrow \operatorname{C}_{6}\operatorname{H}_{12}\operatorname{O}_{6(g)} + 6 \operatorname{H}_{2}\operatorname{O}_{(l)}$$

$$6 \operatorname{CO}_{2(g)} + 12 \operatorname{H}_{2}\operatorname{O}_{(l)} \longrightarrow \operatorname{C}_{6}\operatorname{H}_{12}\operatorname{O}_{6(g)} + 6 \operatorname{H}_{2}\operatorname{O}_{(l)} + 6 \operatorname{O}_{2(g)}$$

It is more appropriate to write the reaction as given above because water molecules are also produced in the process of photosynthesis.

The path of this reaction can be investigated by using radioactive H<sub>2</sub>O<sup>18</sup> in place of H<sub>2</sub>O.

(b)  $O_2$  is produced from each of the two reactants  $O_3$  and  $H_2O_2$ . For this reason,  $O_2$  is written twice.

The given reaction involves two steps. First,  $O_3$  decomposes to form  $O_2$  and  $O_2$ . In the second step,  $H_2O_2$  reacts with the O produced in the first step, thereby producing  $H_2O$  and  $O_2$ .

$$O_{3(g)} \longrightarrow O_{2(g)} + O_{(g)}$$

$$\frac{H_2O_{2(l)} + O_{(g)}}{H_2O_{2(l)} + O_{3(g)}} \longrightarrow H_2O_{(l)} + O_{2(g)} + O_{2(g)}$$

The path of this reaction can be investigated by using  $H_2O_2^{18}$  or  $O_3^{18}$ .

#### Q10:

The compound AgF<sub>2</sub> is an unstable compound. However, if formed, the compound acts as a very strong oxidizing agent. Why?

#### Answer :

The oxidation state of Ag in AgF<sub>2</sub> is +2. But, +2 is an unstable oxidation state of Ag. Therefore, whenever AgF<sub>2</sub> is formed, silver readily accepts an electron to form Ag<sup>+</sup>. This helps to bring the oxidation state of Ag down from +2 to a more stable state of +1. As a result, AgF<sub>2</sub> acts as a very strong oxidizing agent.

#### Q11 :

Whenever a reaction between an oxidising agent and a reducing agent is carried out, a compound of lower oxidation state is formed if the reducing agent is in excess and a compound of higher oxidation state is formed if the oxidising agent is in excess. Justify this statement giving three illustrations.

#### Answer :

Whenever a reaction between an oxidising agent and a reducing agent is carried out, a compound of lower oxidation state is formed if the reducing agent is in excess and a compound of higher oxidation state is formed if the oxidising agent is in excess. This can be illustrated as follows:

(i)  $P_4$  and  $F_2$  are reducing and oxidising agents respectively.

If an excess of  $P_4$  is treated with  $F_2$ , then  $PF_3$  will be produced, wherein the oxidation number (O.N.) of P is +3.

$$P_4(\text{excess}) + F_2 \longrightarrow P F_3$$

However, if  $P_4$  is treated with an excess of  $F_2$ , then  $PF_5$  will be produced, wherein the O.N. of P is +5.

$$P_4 + F_2(excess) \longrightarrow \stackrel{+5}{P} F_5$$

(ii)K acts as a reducing agent, whereas O<sub>2</sub>is an oxidising agent.

If an excess of K reacts with  $O_2$ , then  $K_2O$  will be formed, wherein the O.N. of O is  $\hat{a} \in 2$ .

$$4K(excess) + O_2 \longrightarrow 2K_2 \vec{O}$$

However, if K reacts with an excess of  $O_2$ , then  $K_2O_2$  will be formed, wherein the O.N. of O is  $\hat{a} \in 1$ .

$$2K + O_2(excess) \longrightarrow K_2 O_2$$

(iii)C is a reducing agent, while O<sub>2</sub>acts as an oxidising agent.

If an excess of C is burnt in the presence of insufficient amount of  $O_2$  then CO will be produced, wherein the O.N. of C is +2.

$$C(excess) + O_2 \longrightarrow CO$$

On the other hand, if C is burnt in an excess of O<sub>2</sub>, then CO<sub>2</sub>will be produced, wherein the O.N. of C is +4.

$$C + O_2(excess) \longrightarrow CO_2$$

#### Q12 :

How do you count for the following observations?

(a) Though alkaline potassium permanganate and acidic potassium permanganate both are used as oxidants, yet in the manufacture of benzoic acid from toluene we use alcoholic potassium permanganate as an oxidant. Why? Write a balanced redox equation for the reaction.

(b) When concentrated sulphuric acid is added to an inorganic mixture containing chloride, we get colourless pungent smelling gas HCI, but if the mixture contains bromide then we get red vapour of bromine. Why?

#### Answer :


(a) In the manufacture of benzoic acid from toluene, alcoholic potassium permanganate is used as an oxidant because of the following reasons.

(i) In a neutral medium, OH<sup>ae<sup>-</sup></sup> ions are produced in the reaction itself. As a result, the cost of adding an acid or a base can be reduced.

(ii) KMnO<sub>4</sub> and alcohol are homogeneous to each other since both are polar. Toluene and alcohol are also homogeneous to each other because both are organic compounds. Reactions can proceed at a faster rate in a homogeneous medium than in a heterogeneous medium. Hence, in alcohol, KMnO<sub>4</sub> and toluene can react at a faster rate.

The balanced redox equation for the reaction in a neutral medium is give as below:

(b) When conc.  $H_2SO_4$  is added to an inorganic mixture containing bromide, initially HBr is produced. HBr, being a strong reducing agent reduces  $H_2SO_4$  to  $SO_2$  with the evolution of red vapour of bromine.

$$2NaBr + 2H_2SO_4 \longrightarrow 2NaHSO_4 + 2HBr$$
$$2HBr + H_2SO_4 \longrightarrow Br_2 + SO_2 + 2H_2O$$
(red vapour)

But, when conc.  $H_2SO_4$  is added to an inorganic mixture containing chloride, a pungent smelling gas (HCI) is evolved. HCI, being a weak reducing agent, cannot reduce  $H_2SO_4$  to  $SO_2$ .

$$2NaCl + 2H_2SO_4 \longrightarrow 2NaHSO_4 + 2HCl$$

Why does the same reductant, thiosulphate react differently with iodine and bromine?

#### Answer :

The average oxidation number (O.N.) of S in  $S_2O_3^{2-}$  is +2. Being a stronger oxidising agent than  $I_2$ ,

Br<sub>2</sub>oxidises  $S_2O_3^{2-}$  to  $SO_4^{2-}$ , in which the O.N. of S is +6. However, I<sub>2</sub> is a weak oxidising agent. Therefore, it oxidises  $S_2O_3^{2-}$  to  $S_4O_6^{2-}$ , in which the average O.N. of S is only +2.5. As a result,  $S_2O_3^{2-}$  reacts differently with iodine and bromine.

#### Q15 :

Justify giving reactions that among halogens, fluorine is the best oxidant and among hydrohalic compounds, hydroiodic acid is the best reductant.

#### Answer :

 $F_2$  can oxidize  $Cl^{ae^{\alpha}}$  to  $Cl_2$ ,  $Br^{ae^{\alpha}}$  to  $Br_2$ , and  $l^{ae^{\alpha}}$  to  $l_2$  as:

$$\begin{split} & F_{2(aq)} + 2CI^{-}_{(s)} \longrightarrow 2F^{-}_{(aq)} + CI_{(g)} \\ & F_{2(aq)} + 2Br^{-}_{(aq)} \longrightarrow 2F^{-}_{(aq)} + Br_{2(l)} \\ & F_{2(aq)} + 2I^{-}_{(aq)} \longrightarrow 2F^{-}_{(aq)} + I_{2(s)} \end{split}$$

On the other hand,  $Cl_2$ ,  $Br_2$ , and  $I_2$  cannot oxidize  $F^{ac}$  to  $F_2$ . The oxidizing power of halogens increases in the order of  $I_2 < Br_2 < Cl_2 < F_2$ . Hence, fluorine is the best oxidant among halogens.

HI and HBr can reduce  $H_2SO_4$  to  $SO_2$ , but HCI and HF cannot. Therefore, HI and HBr are stronger reductants than HCI and HF.

$$2HI + H_2SO_4 \longrightarrow I_2 + SO_2 + 2H_2O$$

$$2HBr + H_2SO_4 \longrightarrow Br_2 + SO_2 + 2H_2O_3$$

Again, I<sup>ae</sup> can reduce Cu<sup>2+</sup> to Cu<sup>+</sup>, but Br<sup>ae</sup> cannot.

$$4I_{(aq)}^{-} + 2Cu_{(aq)}^{2+} \longrightarrow Cu_2I_{2(s)} + I_{2(aq)}$$

Hence, hydroiodic acid is the best reductant among hydrohalic compounds.

Thus, the reducing power of hydrohalic acids increases in the order of HF < HCl < HBr < HI.

#### Answer :

The given reaction occurs because  $XeO_6^{4-}$  oxidises  $F^-$  and  $F^-$  reduces  $XeO_6^{4-}$

In this reaction, the oxidation number (O.N.) of Xe decreases from +8 in  $XeO_6^{4-}$  to +6 in XeO<sub>3</sub> and the O.N. of F increases from  $\hat{a} \in 1^{4-1}$  in  $F^{ae}$  to 0 in  $F_2$ .

Hence, we can conclude that  $Na_4XeO_6$  is a stronger oxidising agent than F<sup>act</sup>

Hence, we can say that Ag<sup>+</sup> is a stronger oxidising agent than Cu<sup>2+</sup>.





#### Answer :

In disproportionation reactions, one of the reacting substances always contains an element that can exist in at least three oxidation states.

(a) P, CI, and S can show disproportionation reactions as these elements can exist in three or more oxidation states.

(b) Mn, Cu, and Ga can show disproportionation reactions as these elements can exist in three or more oxidation states.

#### Q25 :

In Ostwald's process for the manufacture of nitric acid, the first step involves the oxidation of ammonia gas by oxygen gas to give nitric oxide gas and steam. What is the maximum weight of nitric oxide that can be obtained starting only with 10.00 g. of ammonia and 20.00 g of oxygen?

#### Answer :

The balanced chemical equation for the given reaction is given as:

But the available amount of  $O_2$  is 20 g.

Therefore,  $O_2$  is the limiting reagent (we have considered the amount of  $O_2$  to calculate the weight of nitric oxide obtained in the reaction).

Now, 160 g of  $O_2$  gives 120g of NO.

Therefore, 20 g of  $O_2$  gives 160 g of N, or 15 g of NO.

Hence, a maximum of 15 g of nitric oxide can be obtained.

(i) AgNO<sub>3</sub> ionizes in aqueous solutions to form Ag<sup>+</sup> and  $NO_3^-$  ions.

On electrolysis, either Ag<sup>+</sup> ions or H<sub>2</sub>O molecules can be reduced at the cathode. But the reduction potential of Ag<sup>+</sup> ions is higher than that of H<sub>2</sub>O.

$$Ag^{+}_{(aq)} + e^{-} \longrightarrow Ag_{(s)}; E^{\circ} = +0.80V$$
  
$$2H_{2}O_{(l)} + 2e^{-} \longrightarrow H_{2(g)} + 2OH^{-}_{(aq)}; E^{\circ} = -0.83V$$

Hence,  $Ag^+$  ions are reduced at the cathode. Similarly, Ag metal or  $H_2O$  molecules can be oxidized at the anode. But the oxidation potential of Ag is higher than that of  $H_2O$  molecules.

Therefore, Ag metal gets oxidized at the anode.

(ii) Pt cannot be oxidized easily. Hence, at the anode, oxidation of water occurs to liberate O<sub>2</sub>. At the cathode, Ag<sup>+</sup> ions are reduced and get deposited.

(iii)  $H_2SO_4$  ionizes in aqueous solutions to give  $H^+$  and  $\frac{SO_4^{2-}}{100}$  ions.

On electrolysis, either of  $H^+$  ions or  $H_2O$  molecules can get reduced at the cathode. But the reduction potential of  $H^+$  ions is higher than that of  $H_2O$  molecules.

$$2H_{(aq)}^{+} + 2e^{-} \longrightarrow H_{2(g)}; E^{\circ} = 0.0V$$
  
$$2H_{2}O_{(aq)} + 2e^{-} \longrightarrow H_{2(g)} + 2OH_{(aq)}^{-}; E^{\circ} = -0.83V$$

Hence, at the cathode,  $H^+$  ions are reduced to liberate  $H_2$  gas.

On the other hand, at the anode, either of  $SO_4^{2^-}$  ions or H<sub>2</sub>O molecules can get oxidized. But the oxidation of involves breaking of more bonds than that of H<sub>2</sub>O molecules. Hence,  $SO_4^{2^-}$  ions have a lower oxidation potential than H<sub>2</sub>O. Thus, H<sub>2</sub>O is oxidized at the anode to liberate O<sub>2</sub> molecules.

(iv) In aqueous solutions, CuCl₂ ionizes to give Cu<sup>2+</sup> and Cl<sup>a€</sup> ions as:

$$2\mathrm{H}_{2}\mathrm{O}_{(l)} \longrightarrow \mathrm{O}_{2(g)} + 4\mathrm{H}_{(aq)}^{+} + 4\mathrm{e}^{-}; \mathrm{E}^{\circ} = -1.23\mathrm{V}$$

But oxidation of  $H_2O$  molecules occurs at a lower electrode potential than that of  $Cl^{ae}$  ions because of over-voltage (extra voltage required to liberate gas). As a result,  $Cl^{ae}$  ions are oxidized at the anode to liberate  $Cl_2$  gas.

Q28 :

Arrange the following metals in the order in which they displace each other from the solution of their salts. Al, Cu, Fe, Mg and Zn.

# <mark>∛S</mark>aral

#### Answer :

A metal of stronger reducing power displaces another metal of weaker reducing power from its solution of salt.

The order of the increasing reducing power of the given metals is Cu < Fe < Zn < Al < Mg.

Hence, we can say that Mg can displace AI from its salt solution, but AI cannot displace Mg.

Thus, the order in which the given metals displace each other from the solution of their salts is given below:

Mg>Al> Zn> Fe,>Cu

Q29 :

Given the standard electrode potentials,

K<sup>+</sup>/K = -2.93V, Ag /Ag = 0.80V,

 $Hg^{2+}/Hg = 0.79V$ 

Mg<sup>2+</sup>/Mg = -2.37V. Cr /Cr = -0.74V

Arrange these metals in their increasing order of reducing power.

#### Answer :

The lower the electrode potential, the stronger is the reducing agent. Therefore, the increasing order of the reducing power of the given metals is Ag < Hg < Cr < Mg < K.

#### Q30:

Depict the galvanic cell in which the reaction  $Zn(s) + 2Ag^{(aq)} \rightarrow Zn^{2}(aq) + 2Ag(s)$  takes place, further show:

(i) which of the electrode is negatively charged,

(ii) the carriers of the current in the cell, and

(iii) individual reaction at each electrode.

#### Answer :

The galvanic cell corresponding to the given redox reaction can be represented as:

$$\operatorname{Zn} |\operatorname{Zn}_{(aq)}^{2+}| |\operatorname{Ag}_{(aq)}^{+}| \operatorname{Ag}$$

(i) Zn electrode is negatively charged because at this electrode, Zn oxidizes to Zn and the leaving electrons accumulate on this electrode.

(ii) lons are the carriers of current in the cell.

(iii) The reaction taking place at Zn electrode can be represented as:

$$Zn_{(s)} \longrightarrow Zn_{(aq)}^{2+} + 2e^{-}$$

And the reaction taking place at Ag electrode can be represented as:

 $Ag^+_{(aq)} + e^- \longrightarrow Ag_{(s)}$
